NOTICE OF ELECTRONIC SPECIAL MEETING, PUBLIC HEARING, AND SUMMARY OF PROPOSED ORDINANCE

NOTICE IS HEREBY GIVEN that the Township Board of the Township of Moffatt will be holding a special meeting on January 7, 2021 at 5 p.m. The purpose of the meeting is to hold a public hearing on an ordinance to join the National Flood Insurance Program and consider any business to come before the Township Board as permitted by law. This meeting will only be held electronically pursuant to the Open Meetings Act and the Michigan Department of Health and Human Services (MDHHS) Epidemic Orders.

Pursuant to the Open Meetings Act, Act 267 of 1976, and the MDHHS Epidemic Orders, the Township Board also gives notice of the following:

1. Reason for Electronic Meeting. The Township Board is holding the meeting by electronic means only because of the gathering restrictions and social distancing requirements set forth in the MDHHS Epidemic Order in effect at the time of this notice and due to health and safety concerns related to the COVID-19 pandemic.
2. Procedures. The public may participate in the meeting and may make public comment electronically by video or telephone conference using the following information:

Copies of the proposed ordinance are available for examination at the office of the Township Clerk and copies may be provided at a reasonable charge. The following is a summary of the proposed ordinance.

ORDINANCE ADDRESSING FLOODPLAIN MANAGEMENT PROVISIONS OF THE STATE CONSTRUCTION CODE

Section 1 of the proposed ordinance provides the agency designated to enforce and discharge the provisions of PA 230 of 1972 within the corporate limits of the Township.

Section 2 provides that Appendix G of the Michigan Building Code shall be enforced by the enforcing agency within the jurisdiction of the Township.

Section 3 adopts by reference the Federal Emergency Management Agency Flood Insurance Study and Rate Map(s) for the purpose of administration of the Michigan Construction Code, declared to be part of section 1612.3 of the Michigan Building Code and to provide the content of the "Flood Hazards" section of Table R301.2(1) of the Michigan Residential Code.

Section 4 repeals all ordinances inconsistent with the provisions of the ordinance.

Section 5 provides the effective date of the ordinance.
