Zoning administer that the family has been contacted and has said they will work on cleaning up the pile also it hasn't been 30 days per the notice says. Wanted to know what the grass length ordinance was as there's many properties with overgrown yards. Z.A. and Supervisor we don't have grass ordinance. The 4 members present of Eimers subdivision would like to change the subdivision would like to change the road from a private road to public road. Ray gave them the Road Commission number to ask how. Alyce, said thank you for the Alger triangle looking nice. Sam – how long does a house have to be completed- Z.A. a special use permit needs to start within 12 months.

Meeting minutes of July 18<sup>th</sup>, public hearing Kevin supported, and Lenny supported and previous month regular board meeting reviewed motioned by Kevin to accept as is and Lee supported. carried.

Supervisor Report: Road Report: Seder is done. Logging will start this week on Forest LK common grounds. About 1 month before paving on S. Forest Lk. County will also be doing Maple Ridge. Do we want one more roadside mowing before winter and road brine. Lenny motion and Stefanie supported; motion passed. Resident had called Road Commission to take down the 25 mph signs as he put them up at Forest Lk Property Owners

Request and FLPO paid for them to be put up not county. also stating that they don't meet the required setbacks and required post. Road commission called Twp board to ask if we were against them being taken down, Twp board took natural path as we did not put up the signs.

Gypsy moth do we want to do the survey again for this year to spray? We have enough in the budget for one more year without asking for a new millage. \$3150 plus \$800 fee. Lee motion and Lenny support. Motion passed.

Treasurers Report: Stefanie motioned, and Lee supported to accept treasure report as is. New Lock Drop off box in Fire Hall lobby.

Clerk Report: Cemetery report – there is an 8-plot lot that is completely stamped concrete over completely.

Bills/Communication: Stefanie motioned to pay election workers and Lenny supported. Motion from Ray to pay bills including the MTA dues and legal fee and Lee supported.

Old Business: Lenny motion and Kevin supported to pass ORV Connection Ordinance on the overpass going over 76 to Brock Rd. Roll Call Vote- Lenny- yes, Stefanie – yes, Ray-yes, Kevin- yes, Lee- yes.

New Hall: Committee presented request for plans of old hall remodeling and new addition to current fire hall of offices only to use the ARPA funds and work on rental hall addition later.

New Business: Do we want to stay with current auditors. Stefanie motion and Lee supported to continue using SOME CPAS out of Rose City. 2% grant request- fire dept and P&R is still thinking. Twp is asking for \$50,000 match hall renovation & offices. Kevin motion and Lee supported.

Planning/Zoning: John gave planning commission update, of still more changes. Zoning Administer John gave his report. Zoning Administer is now using the Twp Clerk Mailbox 58. Discussion on Zoning Administer contract that expires 08-31-2022. Increase to salary of \$600 a month. \$100 monthly millage voucher. Court appearance \$125 and no show court appearance \$50. Reimburse for office supplies. With a 2-week departure notice. Lenny motioned and Lee supported. Roll call vote – Lenny – yes. Stefanie-yes. Ray- yes, Kevin -yes, Lee-yes

Fire Dept: Runs reviewed, Rick was asked about the status of cleaning the hall. He said he will get it. 5 runs. No new truck status update,

Parks & Recreation: Will be working the concession stand at the Forest Lake Craft Show. Looking forward to Halloween and Christmas parties. Taking names for food baskets in Dec.
