Public Comment: Tammy Spencer- We need a light out in Fire Hall parking lot. Who pays when headstones are damaged by act of God.? Tom Spencer – asked to be on agenda for bills and fire dept.

Previous meeting minutes reviewed, motion by lee and supported by Kevin to accept the Regular Meeting minutes as is. Special meeting minutes from 10-29-22 motioned by Lee and Supported by Kevin to accept as is.

Supervisor Report:

The special meeting from 10-29-22 was to take off N. Forest Lake and replace with 600ft of S.Forest Lake additional to the already laying pavement. We are placing Forest Lake and Wilderness at top of priority list for next paving projects.

Gypsy Moth report: We do need to spray again, no report, but recommends 950 acres this year compared to 1250 last year. We still have enough millage money yet for one more year.

The person who authorized the cement company to pour 9.10 x 9.10 cement slab that was done over a whole family plot, is not wanting to remove it after Stefanie and Ray contacted him. This goes against the cemetery ordinance. Ray contacted Attorney- she said you can do 2 things, leave it or dig it up. If leave it, it does not set a presentence for future.

Tabled for next month. Discussion on how to get the ordinance posted in cemetery. Clerk does give a copy to families when they are sold a lot.

Vognta Zoning Administer update Vogtamn Franchise agreement was discussed as Lee and Rick Vogtman was present for further clarification. Question was brought up about getting service out in Bear Creek, it is just feasible at this time. Kevin motioned and Lee supported to pass the franchise agreement.

Treasurer Report: Motioned by Lee and supported by Stefanie to accept as is. Tax bills go out Dec 1st with 2023 newsletter

Clerk Report: Asked for list of Election Workers pay to be approved. Ray motioned and Kevin supported.

Bills/Correspondences: Tom Spencer brought up bills not getting paid by clerk discussion. Lee motioned, & Kevin supported to pay bills as is.

New Business: Snow Plowing bids opened. Ryan Luke of Perrferred concrete submitted only bid and was granted the job.

Old Business: ORV Connector had a good meeting M-Dot, Public Hearing at next Twp Meeting on Dec 19th at 5:30pm. Will send letters to property owners adjacent to route. This new Orv route is only from May to Oct.

Old Hall- what to do with it? Discussion – no vote.

New hall Committee: Submitted plans to Benjamin and will get a meeting together.

Planning and Zoning: John gave his report, planning commission have moved the meetings from 3rd to second Thursday of month. Greg Perplenski talked about is displeasure of the Zoning Administrator coming on his property for a building he is building and demanded the board to Vote to fire the Zoning Administrator. No motion was made.

Fire: Runs 7- small- down power lines. Tom brought up to get a dumpster to clean out fire hall as it's a mess and chief not wanting to clean it. Supervisor will take care of calling Ouellette's for delivery at the training meeting for help. Fire Dept received its 2% grant for gator. Fire Dept asked to approve the purchase from the grant for the gator. Kevin motioned and Lee supported. Passed. Congratulations.

P&R: Kids Christmas Party Sat Dec 10th 1-3pm, Food baskets give away Dec 18th. Discussion on Alger P&R web page, as Marion the old chairperson is upset that the current board does not want the web page and concerned about the future and sent board members a letter. Stefanie (Current President) and Alyce stated the group is good and have a great team and the P&R group voted to take down the page even after paying for a year of service after 1 -1 1/2 years of not using it.
