Public Comment: Resident asked if Twp was Gypsy Moth spraying. - Yes we are
discussed later in Supervisor report.

Minutes of previous meeting reviewed with Lee motion to accept minutes as is and
Lenny supporting- passed

Supervisor Report: Gypsy Moth- spraying apx. 1233 acres, B.O.R.- 16 petitions,
auditor discussion,

Roads - County received safety grant for twp for Yarish Hill for study for possibility of
guard rails and new slopes. County is paving Maple Ridge from M-76 to Moffatt
Bridge. Moffatt bridge will be completely closed for a short period again to finish
project. This years twp funding from county is \$50,000 matching, \$17,000 ARPA
funds, \$10,000 discretionary funds, and Moffatt with \$8,800 matching funds from last
year. We have apx,\$275,000 in our Road Fund. Cost apx \$20,000 for mowing and
brining of Roads. We want to pave a least 1mile of stretch. with ideas of possible work
on paving Wilderness, and Elk horn and South Forest Lake, gravel for Sheldon and Buhl
in town.

New Hall/Offices- after discussion people want a separate Twp hall for seating of 125,
Full commercial Kitchen and offices. we have CD money and ARPA fund money. could
take a loan out for \$500,000.

Treasurer Report: Supervisor Read - Stefanie motioned and Lee supported to accept as
is. Passed

2% Grants - Twp to apply for \$9,000 matching funds from APR A Funds for engineered
plans, fire dept to apply for SCBA'S - for \$44,000 with \$10,000 matching funds coming
from fire fund. No submission from p&r. Lee motioned to accept grants request and
Stefanie Supported.

Bills -Lenny motioned and Lee supported to pay bills as presented.

Correspondence: Residents frustrated with DTE contract for natural gas asking lines to be expanded. Discussion and Clerk will write to DTE to see what the plans are but contract is very vague.

Dog Park/Disc Golf - Front Big Diamond to use for Dog Park, and looking for like 9 disc golf stations. Will continue to work on projects.

Clerk Report- Clerk Laptop estimate came in - \$1108. Lenny motioned and Lee supported to buy clerks laptop for \$1108. passed Update pavilion rental form- keep rental at \$50, will add \$50 deposit, please pay with separate check.

Lawn Care: After discussion, twp decided not to buy own lawn care equipment, will but out the job forbids due at next Twp Meeting.

Free Dump Day discussion. After Discussion Ray motioned and Stefanie supported the twp free dump day will be 1st sat of June during regular trash hours 9-12. 2- 40 yard dumpsters.

Planning: Working on RV ordinance, need lawyer to go over a couple things. John gave report. Johns post box is up soon, he said if its ok to use clerks Twp box he will do that as he doesn't receive a lot of mail in his for the cost. Clerk agreed.

Fire Dept: Selling the old 1971 Ford Fire Truck at live Auction at Twp meeting with Supervisor being the auctioneer. Will put in paper and web page, social media, and twp posting on door. 2 runs. Working with twp and Emergency manger and Red Cross to be warming center and eventually be able to house over night. Tabled insurance/ consumers billing.
